Good evening,

It has come to the attention of RELX that there are a number of miscommunications about the exact relationship that RELX and LexisNexis has with Homeland Security and ICE, specifically. Please read the official position below:

LexisNexis Legal & Professional has one contract with the U.S. Department of Homeland Security. This contract provides immigration detainees with free access to a customized LexisNexis legal research service so they can better understand their rights, mount legal defenses, and prepare appeals. The service includes immigration law materials as well as user guides in English and Spanish.

LexisNexis Legal & Professional products are often used by law students at universities to provide pro bono legal support for undocumented immigrants and detainees. LexisNexis Legal & Professional does not sell or license searches from its products to U.S. Immigration and Customs Enforcement or any other government or commercial organization.

A sister company, LexisNexis Risk Solutions has two contracts with the U.S. Department of Homeland Security.

- 1. In March 2021, LexisNexis Risk Solutions began a five-year contract worth \$16m (\$3.2m annually) to provide an investigation tool for the Department of Homeland Security's U.S. Immigration and Customs Enforcement. The tool promotes public safety and is not used to prevent legal immigration nor is it used to remove individuals from the United States unless they pose a serious threat to public safety including child trafficking, drug smuggling, and other serious criminal activity. This contract was signed after President Biden's Executive Order 13993 of January 21, 2021, which revised Homeland Security's civil immigration enforcement policies and priorities, emphasizing human rights and focusing on threats to national security, public safety, and security at the border.
- 2. The second contract enables the U.S. Department of Homeland Security's Immigration and Customs Enforcement to vet its employees for insider threat activities. The contract is not related to immigration.
